Appointment of the Officers in Grade I of the Sri Lanka Teacher Educators' Service to the Posts -2019

As mentioned in the Sri Lanka Teacher Educators' Service Minute published in the Gazette Extraordinary No. 1925/37 dated 28.07.2015, applications are invited from the officers who have fulfilled qualifications to appoint the officers in Grade I of the Sri Lanka Teacher Educators' Service to the following posts existing in 18 National Colleges of Education and 07 Teachers' Colleges under the purview of the Ministry of Education as per the Order issued by the Education Services Committee of the Public Service Commission. Applications prepared according to the specimen application form indicated at the end of this notification should be sent through registered post to reach, "Assistant Secretary, Teacher Educators' Branch, Ministry of Education, 'Isurupaya', Pelawatta, Battaramulla on or before the date mentioned below. The term, "Appointment of the Officers in Grade I of the Sri Lanka Teacher Educators' Service to the Posts - 2019" should be clearly mentioned on the top left hand corner of the envelope.

I. Posts

- (i) President of the National Colleges of Education
- (ii) Principal of the Teachers' Colleges
- (iii) Vice President of the National Colleges of Education

(Posts and service stations where vacancies exist have been indicated in Schedule I)

II. The closing date of entertaining application – 02.09.2019

02. Method of Selection:

- I. Officers will be recruited to the posts by the Education Services Committee of the Public Service Commission based on the results of the structured interview conducted by a Board of Interviewers appointed by the Education Services Committee of the Public Service Commission and in accordance with the preference of the applicant and the service requirement and also considering the recommendation of the Secretary of the Ministry of Education subsequent to calling applications from the officers who have qualified for the above mentioned posts as per Para 11 of the Sri Lanka Teacher Educators' Service Minute published in the Gazette Extraordinary No. 1925/37 dated 28.07.2015 of the Democratic Socialist Republic of Sri Lanka.
- II. Officers who have scored 35 marks or marks higher than 35, the minimum for passing the structured interview will be selected for appointing to the relevant posts as per the Schedule V of the Sri Lanka Teacher Educators' Service Minute.
- III. The scheme of giving marks for the structured interview has been indicated in the Schedule II of this notification.
- IV. Service stations and the posts that the officer prefers to apply should be stated under Para 08 of the application. If the officer has served at least for 05 years in the current place of work, he should not apply for the same place of work. In case the officer is not qualified to hold the post that he/she has requested according to the merit, consideration is given to appoint the officer to a post in another service station based on the requirement.

- V. Appointment to a post is considered only in this phase according to the merit obtained at this interview and the merit obtained is not considered for the appointments made during the time until when an interview is conducted for appointing to the posts again.

03. Qualifications:

- I. Being an officer in Grade I who has passed the 03rd Efficiency Bar Examination of the Sri Lanka Teacher Educators' Service.
- II. An active and satisfactory period of service in which the officer has not subjected to any disciplinary punishments during the immediate 05 years should be completed by the officer during the immediate 05 years.
- III. All the educational and additional qualifications should have to be completed prior to the closing date of calling applications.
04. The relevant structured interview will be conducted at the Ministry of Education, Isurupaya. The date of conducting the interview will be notified later. The decision of the Education Services Committee of the Public Service Commission will be the final decision related to appointing the officers to the posts.
05. In case of any inconsistency prevails in the texts of this Gazette notification published in the Sinhala, Tamil and English Languages, the Sinhala text will prevail.
